BY THE NORTH CAROLINA RURAL ELECTRIFICATION AUTHORITY
("Authority"):

On May 3, 2013, the Authority received Time Warner Cable Information Services' (North Carolina) (hereinafter "TWCIS") Petition for Partial Reconsideration of Order Issued April 2, 2013.

The petition requests that TWCIS and Star TMC (hereinafter "Star") commence arbitration of an interconnection agreement between the parties in parallel with the adjudication of Star's Section 251(f)(2) petition.

IT IS, THEREFORE, ORDERED as follows:

1. That no later than Friday, May 17th, 2013, Star shall file a response to TWCIS's petition for Partial Reconsideration of Order.
2. A hearing will be held on Monday, May 20th, 2013 for the parties to present oral arguments regarding the Petition for Partial Reconsideration.


3. The hearing will be held in Room 2115 of the Dobbs Building, 430 N. Salisbury Street, Raleigh, NC 27603 and will begin at 1:00 p.m.
4. TWCIS will have thirty (30) minutes to present its argument to the Authority.
5. Star will have thirty (30) minutes to present its argument to the Authority.
6. A party who wishes to waive its right to present oral arguments to the Authority shall make its intention known in writing to be filed with the Authority no later than Friday, May 17th, 2013.
